

**Intro: OnceFallen & Informational Corrlinks Newsletter (ICoN) Services (Last Update 01/30/23)**

This intro explains what the OnceFallen.com offers & doesn't offer. If you wrote to SOSEN.org, you are receiving this notice because SOSEN doesn't have an inmate outreach; I respond to inquiries on their behalf. If, for some reason, the institution won't allow you to write to Derek Logue or OnceFallen you can write to me using the SOSEN name at the same address. Due to a limited budget & manpower, I do NOT have a regular physical mailing list for these newsletters. Those with Internet access can read & print past issues from my site & the other resources I offer at <https://oncefallen.com/icon/>

I'm a one-man operation that receives hundreds of letters & emails a year, so please do the following when contacting me to ensure I can respond to your requests:

- Please write legibly (print rather than cursive, & no fancy script). Typed is best.
- ALWAYS place your return address on your letter EXACTLY as the prison wants it listed in order to ensure you get a proper response, EVEN IF you've written me before.
- If requesting info, be sure you have the RIGHT return address. Many prisons are now requiring me to send letters to a private business not the prison. Also be aware that many prisons place rules on mail (Examples: 5 single sided pages, 5 double sided pages, cannot use "security lined" envelopes, only B&W stamps, etc.) Even if you've written me before, please add reminders to prison mail policy if making a request.
- Make checks/ MOs out to Derek Logue for donations/ paying for printouts; if sending stamps, please send stamps I can easily peel & place on envelopes. For every 5 pages printed that's a stamp.
- When emailing me on Corrlinks, please make a separate email for questions; DO NOT hit "direct reply" to an ICoN newsletter to ask your question because there's never enough room to respond.
- If sending SASEs, do not place your mailing labels on them, as your prison will reject them.
- If a letter is returned to me, I may try resending once. If it returns a 2nd time I give up.
- Rude, inconsiderate, & ungrateful people will be blocked with zero warning.

**ABOUT THE ICoN**

As part of OnceFallen.com's prisoner outreach, the ICoN was started in May 2015 to provide a short summary of legal news, articles of interest, & resources on SO-related topics primarily to help prepare those for "life on the list." The monthly ICoN will typically contain a very brief summary of SO-related legal news & various articles of interest.

Because of Corrlink's roughly 12,500 character limit, ICoN frequently uses abbreviations for states & courts, & these acronyms, so get acquainted with them: SCOTUS (Supreme Court of the United States), ARM (anti-registry movement), AWA (Adam Walsh Act, the federal registry law), SOR (SO-Registry), SORNA (SO-Registry & Notification Act), & FTR (Failure to Register). Due to the negative connotations, we discourage the use of SO as much as possible, Person Forced to Register (PFR), RC (Registered Citizen), RP (Registered Person), or Registrant to describe those who are released & on the public registry. SO is generally used sparingly & for those not yet released from incarceration.

## ABOUT ONCE FALLEN

I am Derek Logue, a PFR, an activist since 2004, & host of the info site OnceFallen.com since 2007. I have a BS in Justice Studies (Athens State U. in AL) & have made a handful of media appearances over the years, including HLN, Russia Today, & CNN, as well as various local media outlets across the US. I engage in public demonstrations as well as speaking before lawmakers. I am regarded as one of the most knowledgeable individuals on the subject of "SOR" Laws in the US. I treat this as a full-time job, despite not being paid or funded in any way save for a handful of donations.

My primary function is running the Once Fallen informational site, which includes collecting, organizing, & writing articles on various topics related to the registry, residency restriction laws, or other issues of primary concern of those forced to register. The ICoN is just one of the many projects that I do in an attempt to disseminate relevant information. All of the information on my website [www.oncefallen.com](http://www.oncefallen.com) is free to the general public for non-commercial use (i.e., personal reading & research, sharing with others, using pages as part of info packets when writing to legislators, & similar uses).

What we **DO NOT** offer under ANY circumstances:

- Legal Services, appeals issues, & attorney referrals: Any opinion I offer is just my opinion as an activist with some legal knowledge. State Bars or Legal Aid societies offer these services;
- News on sentencing guidelines, prison-related issues or legal news not relevant to SO laws: We may cover a subject related to these issues from time to time but will not be able to answer questions related to these topics;
- Pen Pals, People-Finding Services, or message forwarding services of any kind;
- Resources are limited, so I will not print out entire legal statutes or court cases for you except in limited circumstances & will require payment for such requests if I can fulfill them;
- A site for posting prisoner essays & letters, see below for orgs that offers this service.

## “YOUR LIFE ON THE LIST: EDITION 3” by Derek Logue

Your Life on The List: Edition 3 (YLOTL3) is a registry survival guide, covering a variety of common concerns like housing, employment, compliance checks, travel, & other common questions. It also contains a housing list & a comprehensive overview of the registry, residency/ proximity laws, & other post-conviction laws you may experience as a Registered Person. If you are preparing for release, I strongly encourage you to order a copy to be better prepared for release. In fact, I encourage everyone to order the book BEFORE requesting the other guides I offer by mail, since the info in my book contains

most of the info I offer elsewhere (the housing list, however, is frequently updated on my website). There are two ways to obtain a copy (older editions are no longer on sale but are still listed on Amazon):

Physical copies: Physical copies of the book can be purchased from major retailer Amazon.com (the publisher) for \$14.95 plus shipping/tax.

Amazon charges shipping for orders under \$25 so if you buy both books at the same time, shipping is free. If you have no one else who can order the book for you, contact me to work out an arrangement. I do NOT have the funds to send you a free copy. (Generally, I will order on your behalf if you send me \$25 for on book or \$35 for both YLOTL3 & the ARM handbook or two copies of the same book but please ask me first before sending me the money. Your facility MUST allow books ordered direct through Amazon, they aren't sold through other booksellers!)

## **OTHER ICoN/ ONCEFALLEN RESOURCES**

NOTE: Due to ongoing issues with the USPS & continuous changes to mail protocol, I'm no longer printing out past ICoN Newsletters, including consolidated newsletters or the AtwoZ state travel guide or the 50 state “relief from the registry” list. All of these resources I previously offered & more are already listed in my book “Your Life on The List: Edition 2” so I strongly urge you to order a copy before requesting info from me.

I will still answer specific questions about post-release “SO” issues & provide summaries of the laws & housing leads for up to 2 states per request. Please note that if you are a federal prisoner in search of a halfway house, my regular housing list likely won't be of use to you since you MUST gain approval into an accredited federal halfway house.

## **PRISONER RESOURCES**

My focus is not on prisoner needs & issues, but on reentry issues for “SOs.” So I've compiled a few resources that may be of interest to prisoners. Some are not exactly focused on “SO” issues. Some

facilities are banning/censoring certain resources for various alleged violations of their policies. Please check the rules of your institution before writing any of the resources below to see if they are on the banned list. Also, my listing here does not imply these organizations mutually support each other, nor can I guarantee each group will be helpful to you. Info here is subject to change.
