

## ONCEFALLEN.COM INTRO FOR WISCONSIN CORRLINKS USERS

LAST UPDATE 09/02/2023

Please read this intro for everything I do & don't do. I cannot add you to my regular Corrlinks newsletters because of the cost, & I do not have a plan in place to accept paid subscriptions. I do, however, answer direct questions to me through Corrlinks, by letter, or even by phone (cannot accept collect calls).

I'm a one-man operation, so please do the following when contacting me to ensure I can respond to your requests in a timely manner:

- Please write legibly (print rather than cursive, & no fancy script). Typed is best.
- ALWAYS place your return address on your letter EXACTLY as the prison wants it listed in order to ensure you get a proper response, EVEN IF you've written me before.
- If requesting info, be sure you have the RIGHT return address. Many prisons are now requiring me to send letters to a private business not the prison. Also be aware that many prisons place rules on mail (Examples: 5 single sided pages, 5 double sided pages, cannot use "security lined" envelopes, only B&W stamps, etc.) Even if you've written me before, please add reminders to prison mail policy if making a request.
- Make checks/ MOs out to Derek Logue for donations/ paying for printouts; if sending stamps, please send stamps I can easily peel & place on envelopes. For every 5 pages printed that's a stamp.
- When emailing me on Corrlinks, please make a separate email for questions; DO NOT hit "direct reply" to an ICoN newsletter to ask your question because there's never enough room to respond.
- If sending SASEs, do not place your mailing labels on them, as your prison will reject them. Write out your return addresses on the SASE.
- If a letter is returned to me, I may try resending once. If it returns a 2nd time I give up.
- Rude, inconsiderate, & ungrateful people will be blocked with zero warning. Be patient—I take hundreds of inquiries annually without assistance, & the mail is also slow. I am a one-person operation; I respond to each letter personally. While you can receive a response in as little as a few days depending on mail efficiency, please allow up to 2 months for a response.
- Corrlinks emails costs 10 cents per email. This adds up when responding to hundreds of emails. Please make the most of every email & ask all you need to ask in as few emails as possible.

## ABOUT ONCE FALLEN

I am Derek Logue, Registered Person & activist since 2004, & host of the registry law info site OnceFallen.com since 2007. I have a bachelor's degree in Justice Studies (Athens State U. in AL) & have made a handful of media appearances over the years, including the Dr. Drew show, Russia Today, & CNN, as well as various local media outlets across the US. I engage in public demonstrations as well as speaking before lawmakers. I am regarded as one of the most knowledgeable individuals on the subject of

“SOR” Laws in the US. I treat this as a full-time job, despite not being paid or funded in any way save for a handful of donations.

My primary function is running the Once Fallen informational site, which includes collecting, organizing, & writing articles on various topics related to the registry, residency restriction laws, or other issues of primary concern of those forced to register. All of the information found on my website [www.oncefallen.com](http://www.oncefallen.com) is free to the general public for non-commercial use (i.e., personal reading & research, sharing with others, using pages as part of info packets when writing to legislators, & similar uses)

What we **DO NOT** offer under ANY circumstances:

- **Legal Services, appeals issues, prisoner rights & attorney referrals:** Any opinion I offer is just my opinion as an activist with some legal knowledge. State Bars or Legal Aid societies offer these services; do not send me your legal paperwork.
- **News on sentencing guidelines, prison-related issues or legal news not relevant to SO laws:** We may cover a subject related to these issues from time to time but will not be able to answer questions related to these topics;
- **Pen Pals, People-Finding Services, or message forwarding services of any kind;**
- Resources are limited, so I **will not print out entire legal statutes or court cases for you** except in limited circumstances & will require payment for such requests if I can fulfill them;
- **A site for posting prisoner essays & letters**, see below for orgs that offers this service. Please don't send me your life story.

## WI INFO PACKET

In June 2022, I updated an informational packet with housing leads (currently one lead in Milwaukee, wish I had more), a summary of the WI state law, rules for supervision, lifetime GPS, polygraphs, & info on civil commitment. It is 20 pages long & I do update the packet regularly. It is also available as a PDF file on my website (along with other free info for prisoners) at:

PLEASE NOTE BEFORE REQUESTING THE INFO PACKET: While I don't charge money for the printout, I ask for stamps to help offset the cost since stamps are the most expensive part of what I offer. If your facility places no limits on prisoner mail, **I can send you the info packet for 2 stamps or two SASEs**. If your facility limits the printouts to 5 sheets of paper but can be double sided, it is just two stamps/SASEs. But if your facility limits letters to five single sided sheets, it takes 4 stamps/SASEs to mail this out. Send the stamps/SASEs to the address above. Either way, I ask for stamps to offset the costs of sending these packets; I'm already providing the ink & paper & the research.

While I cannot provide the Informational Corrlinks Newsletters (ICoN) to WI prisoners through Corrlinks due to costs, I consolidate 6 months' worth of ICoNs & send them out by mail. They're also around 20 pages each. I only print & send the most recent ones on request (due to cost & time issues), but if you have friends who can print things out for you, all previous ICoNs can be found free of charge through the link I provided.

### **YOUR LIFE ON "THE LIST" Edition 3 (Paperback – January 25, 2023) by Derek W Logue**

“Your Life on The List: Edition 3” is an updated registry survival guide, covering a variety of common concerns like housing, employment, compliance checks, travel, & other common questions. It also contains a housing list & a comprehensive overview of the registry, residency/ proximity laws, & other post-conviction laws you may experience as a Registered Person. If you are preparing for release, I strongly encourage you to order a copy to be better prepared for release. In fact, I encourage everyone to order the book BEFORE requesting the other guides I offer by mail, since the info in my book contains most of the info I offer elsewhere (the housing list, however, is frequently updated on my website). Amazon raised the threshold for free shipping in August 2023 from \$25 to \$35. If you don't have a friend with Amazon Prime, shipping for orders under \$35 is usually \$5.99 for one book, \$1 extra for each additional book. WI sales tax still applies even if someone orders from another state. If you don't have friends who can order books for you, I can do it on your behalf if you send me a \$25 for one book or \$42.50 for 2 books to cover costs. However, contact me first before doing this. Due to lack of funds, **I DO NOT offer free copies of my book**, so please don't ask.
