

Wisconsin Local-Level Restrictions Database for Registered Persons (2025)

ABOUT THIS DATABASE

Wisconsin does not have statewide restriction law in place for Persons Forced to Register; the only exception is that those “On Paper” (probation/parole/supervised release, etc.) cannot establish a residence until registering beforehand. Those On Paper can be banned from residing in certain locations by courts. Those On Paper classified as SVPs cannot be placed within 1500 feet of school premises, child care facility, public park, place of worship, or youth center, nursing homes/assisted living centers, & next door to a child’s residence; must be released only in the county of conviction.

However, many municipalities have the authority under Wis. Stat. §§59.54(6) and (22) to “enact and enforce ordinances to preserve the public peace and good order within the county including, but not limited by enumeration, ordinances prohibiting conduct.” As a result, many municipalities, townships, and counties have imposed residency restriction ordinances upon persons forced to register. Official reports stated that over 150 municipalities have passed some form of residency restriction, and/or proximity or presence restriction. In addition, many local ordinances may include what is known as an “original domicile restriction,” meaning you cannot move into the community UNLESS you had resided in that community before your conviction. This has created a situation where Registered Persons have a difficult time finding housing throughout the state.

This database was first created by Derek W. Logue of OnceFallen.com between May 2025 and October 2025 because no other resource has taken the time to list current restrictions in the state of Wisconsin. Wisconsin is one of a handful of states that have allowed municipalities to create and enforce their own residency restriction laws.

This database was compiled by searching every available website that posts municipal codes for communities within the state. Many links to municipal codes and ordinances can be found at:

Many communities also post ordinances on websites like Municode (<https://library.municode.com/>), American Legal Publishing Corporation (<https://codelibrary.amlegal.com/>) and General Code/eCode360 (<https://ecode360.com/> or <https://www.generalcode.com/>). Some have their own websites. A community is only listed in this database if the municipal codes have been reviewed.

This database is intended to document local-level restrictions in Wisconsin at the time it was reviewed. New ordinances can pass, and existing ordinances can be altered, at any time. While this database could be used as a guide for those seeking to abide by the laws, it is suggested you double-check municipal ordinances to see if changes have been made. A brief discussion on how to conduct your own research is mentioned in this report.

DISCLAIMERS AND STATEMENT OF LIMITATIONS OF THIS REPORT

1. **ACCURACY:** This report was as accurate as within my abilities at the time of release. While I tried to provide the most info possible, some communities created ordinances that are confusing or even incomplete. Also, new ordinances can be passed at any time with little to no news coverage, and some communities may have passed ordinances not published online. Some municipalities have repealed older ordinances and replaced them with new ones; thus, some municipalities may have had residency restrictions before the date listed in the database. This may hinder research into patterns on passage of these ordinances. In this guide, I have added the locations of the ordinances I found within the codes for your convenience, though even the location of the code or ordinance can change at any time. Please check with the local registry office before moving in to ensure there are no restrictions in that area before you move there. If you know of any restrictions not listed in this report or find an error, send it to Derek Logue at iamthefallen1@yahoo.com and please send a copy of the current ordinance as proof.
2. **NOTICE OF EXCEPTIONS:** There ARE some exceptions to each ordinance, so I have added the ordinance number so that you may find the exceptions to the rules.. Some municipal ordinances may apply to all Registered Persons or only apply to those Registered Persons with offenses against minors (those under the ages of 16 to 18 depending on the ordinance, those on supervised release including those on lifetime supervision, those subject to community notification or “Special Bulletin Notice”, or those designated by the state as a “Sexually Violent Predator”, and there are some exceptions to the rules. Generally, exceptions to ordinances include court orders allowing residency or living in the location before a prohibited location opens close to your residence which would place the residence within a restrictive zone. Many municipal codes and ordinances may also contain a provision to apply to a local appeals board to apply for an exception to the rules.
3. **LEGAL DISCLAIMER:** This report is NOT intended to be a treatise on the efficacy or constitutionality of these laws. Information posted here was created for research purposes into the spread of municipal ordinances throughout the state and reflects only ordinances personally reviewed by the author. . The original date of the passage of an ordinance and original ordinance is listed for the sake of documenting potential trends in the spread of residency restrictions and other municipal ordinances. The information posted on restrictions in this report are of the ordinances current at the time of review rather than those of the original ordinance, as ordinances and municipal codes can be amended by later revisions to these codes and ordinances.
4. **NOTICE TO THOSE ON SUPERVISED RELEASE:** Those subject to supervised release, probation, or parole, can face additional restrictions to what is listed here at the discretion of your P.O. In some cases, local-level ordinances provide exceptions to residency restrictions if court-ordered to stay in a location that would otherwise be restricted.
5. **FAIR USE POLICY** This report is free to be disseminated for non-profit/non-commercial use. (Essentially, not to be rebranded and/or resold other than recoup the costs of printing/sending to those who need it). You must give credit to Derek W. UNDERSTANDING THE DATABASE

The Excel database uses the following categories:

1. **Community:** Name of the administrative division. Due to the terminology used by the state, I use “community” instead of “municipality” since unincorporated areas can be “towns” (or townships) with their own rules.
2. **Type:** Wisconsin’s “Administrative divisions” – County, City, Town (or township), or Village. See “Understanding Wisconsin’s Administrative Divisions” for further details.
3. **County:** The county or counties in which the community is located.
4. **Pop:** population of the community
5. **RRs:** (Residency Restrictions) Does the community have a residency restriction law? If yes, numbers are in feet. If a community has residency restrictions, the distance of prohibited areas is typically measured property line to property line, not building to building. This means you need to consult a plat map instead of relying on typical online maps to measure distance.
6. **PR:** Presence or Proximity Restrictions: Typically “anti-loitering,” though some ordinances may say you can’t be present within a certain distance. It does not always match the distance set for residence restrictions. In this category, “OP” is an abbreviation for “on premises”
7. **ODR:** “Original Domicile Restriction” or “Original Residence Rule”, an ordinance barring a Registered Person from moving into the municipality UNLESS they had resided in that municipality before your conviction. Some communities make this rule permanent or for a set number of years after release (often 10 years from release date) and often apply only to those on supervision.
8. **HW:** Restrictions on specific activities during Halloween and/or other holidays (incl. Xmas, Easter) that may include prohibitions on handing out candy, wearing costumes, and putting up displays and decorations
9. **App2:** Applies to, i.e., whether local ordinances apply to all Registrants or only certain offense types, such as “SVPs” (“sexually violent predators”), those subject to a “Special Bulletin Notification” (SBN), those with offenses against those below a certain age (Ex: a law applying to those registrants with offenses against those under age 18 is listed as Off<18), those convicted of sexual assault (SA), those convicted of a “serious child sex offense” (SCSO), those on Supervised Release/probation/parole (SR), or those on Lifetime Supervision (LS).
10. **1stPass:** Date the ordinance was first created, if known. This is usually found in the footnotes sections of municipal codes. (Example: “Added 11-3-2014 by Ord. No. 2043”). However, some municipalities have repealed and replaced their entire municipal codes and ordinances in their entirety. This means a residency restriction law may have existed BEFORE the date posted in this section. This report posts the date of the oldest KNOWN ordinances.
11. **Ord#:** The original ordinance code that created the restrictions, if known; this is often listed in the municipal code.
12. **Municipal Code #s:** Where in the community’s municipal code where the ordinances are found
13. **Prohibited Areas & Additional Notes:** Many prohibited area applies specifically to areas used primarily by minors (anyone under age 18). So when a code/ordinance states a certain area is prohibited, such as an “athletic field”, it is generally those specifically for use by children but can be any place that can be accessed by children. Prohibited locations mentioned like parks or libraries are PUBLIC facilities unless stated it includes PRIVATE. Additional notices, such as certain other restrictions, will be mentioned in the same section of the report as the list of prohibited areas, which can include employment restrictions or other additional penalties worth noting. For the sake of brevity, “incl.” may shorten the phrase “including, but not limited to...” Other restrictions in notes may include job/ license bans or anti-clustering laws

DEFINITIONS USED IN THIS REPORT AND/OR IN ORDINANCES

If you plan on doing your own research or are confused by some of the terminology in this report, here are some common terms you may see while reading municipal ordinances and while reading this report. While there is usually a definitions section in each ordinance, definitions may vary.

- **“980”**: Shorthand for Wisconsin Statutes Ch. 980, dealing with registrants subject to civil commitment. See SVP
- **“Anti-Clustering”**: A law prohibiting so Registered Persons from living in the same residence or near another Registrant.
- **“Child” (or “Minor”)**: In state law, a person who has not attained the age of 18 years, except that for purposes of prosecuting a person who is alleged to have violated a state or federal criminal law, “child” does not include a person who has attained the age of 17 years. However, in some ordinances in this report, a “child” is someone under age 17 or 16 for purposes of the ordinance.
- **“Child Safety Zones”**: Term used often in codes/ordinances that denote the prohibited areas within a community. You will often find a list of prohibited areas under a “definitions” section of the ordinance
- **“Contiguous”**: Any property that touches another property, i.e., is “next door” to the property.
- **“Church” or “place of worship”**: Any building offering religious services, which can include non-traditional religious buildings.
- **“Crimes Against Children”**: The offenses against minors or children generally cited in local ordinances are listed below. State law defines a “child” as anyone under age 18, so any ordinance stating offense against a child but lists no specific age is assumed to follow state laws. Many municipal ordinances will define a child or minor as below ages 16, 17, or 18, but for CP offenses, that age will always be set at 18. For those classified as an SVP, there is seemingly no age limit unless explicitly noted in the ordinance.

- **“Designated Sex Offender”:** Some municipalities limit their ordinances to certain offenses, usually based on age (i.e., any offense against a child or minor), and/or those designated with SVP or SBN statuses.
- **“Facilities for children”:** Any place that has a program primarily or exclusively for minors, which can include any or all the following—public/ private school, group/ residential care center for children/ youth, shelter care facility, foster/ treatment foster home, day care center/ program/ provider, youth center, “Sunday School”/ church, or “specialized” schools (businesses that teach specialized classes like
- **“Incl.”:** Shorthand for “including,” or, more often, “including, but not limited to”
- **“LS”:** Those placed on lifetime supervision
- **“Original Domicile Rule” (ODR, aka Original Residency” rule):** An ordinance that prohibits a Registered Person from residing in a community unless that Registrant lived in that community at the time the offense was committed. This rule is usually intended to prevent placement of “SVPs” or “980s” in the community but may apply to all Registrants. Many of these ordinances have a time limit (usually 10 years from release from incarceration & supervision)
- **“Parks”:** Municipalities often listed all park areas under terms like “park”, “parkway”, “parkland,” and “park facility”, so parks can denote all land considered park of a park, including walking/bike/equestrian (horse) trails, road connecting parts of a park, or parking lots.
- **“Places where children congregate/gather”:** Any place designated to be a location frequented by children in addition to any set locations mentioned in the code/ordinance.
- **“Proximity” or “Presence Restriction” (PRs):** Not allowed to be present in, pass through, and/or loiter inside of a prohibited area
- **Rec.:** Shorthand for “recreational”
- **Resident Agent:** Resident Agent. Any person appointed by the owner of a tourist rooming house (short-term rental) to act as agent on behalf of the owner.
- **RP, Registered Person or Registrant:** A Person Forced to Register (PFR) on the public sex offense registry
- **Short-Term Rental:** Residential rental property for a period less than 30 days (i.e., ArBnB or Vrbo); it generally excludes hotels/motels.
- **Special Bulletin Notification (SBN or SBX):** AKA Community notification. There are three levels of notification assigned by risk –
 - Level I: Notification about the RP is disseminated to law enforcement only.
 - Level II: Notification about the RP is provided to specific individuals & groups, based on the particular facts in the case.
 - Level III: Notification is community wide notification where upon information is disseminated through media & community meetings.
 Most ordinances calling for limits on those “SBN” mean those subject to Tier III community notification)
- **“School”:** Any school offering educational classes to those under age 18, whether public, private, or religious (Pre-K to High School, or Head Start programs)
- **“Specialty School”:** Businesses that teach offer targeted programming like dance/gymnastics/martial arts/music, tutoring places, Montessori schools/ academies, and other places that teach or instruct children.
- **“SCSO”:** “Serious Child Sex Offender”, primarily offenses against a child age<13
- **“SVP”:** A person designated as a “sexually violent predator/ person” or one convicted of an offense deemed violent and sexual in nature; often these are Registrants who were considered eligible for civil commitment.

DOING YOUR OWN RESEARCH IN WISCONSIN'S LOCAL ORDINANCES

If you wish to conduct your own research into local ordinances, the first place you may want to visit is the Wisconsin State Law Library's WI Ordinances & Codes page (<https://wilawlibrary.gov/topics/ordinances.php>). It has direct links to almost every county, township, village, and city ordinance in the state.

Municipalities may also host their ordinances on municipal code websites like Municode (<https://library.municode.com/>), American Legal Publishing Corporation (<https://codelibrary.amlegal.com/>) and eCode360 (<https://ecode360.com/>), all of which have search bar. Some have their own websites.

For those with search bars, you might find ordinances using the following terms: sex, sexual, offender, offense, predator, "feet of", school, or safety zone; you can also use CTRL+F on a web browser to pull up a word search bar and type those words on a page. If you have to read through municipal codes manually, many ordinances will be under chapters covering "Offenses", "Public Safety/ Health/ Welfare", "nuisances", "zoning", "parks" or "miscellaneous offenses". It may generally be titled as "Sex Offender Regulation/ Residency Restrictions" or "Child Safety Zones."

If you do find an ordinance, most follow a similar basic structure:

1. **Statement of Intent, Purpose, or "Recital":** A statement filled with erroneous claims of high recidivism and/or a statement the intent of the ordinances is not to "punish" or be "punitive". The latter statement is meant to shield the municipality from constitutional challenges.
2. **Definitions:** Watch for definitions of what constitutes a "designated sex offender"; in many locations, the term only applies to those with offenses against a person below a certain age or given a specific status like SVP or SBN Registrants rather than against all Registrants. An ordinance may define a "sex offender" as someone who commits offense against a child; then you must look for the definition of a "child."
3. **Prohibitions/Offenses:** The list of prohibited activities. You may have to refer back to definitions to know what places are actually prohibited areas. Pay close to any differences between residency and proximity restrictions; some municipalities add additional areas to proximity restrictions. Ordinances generally apply a prohibition on renters offering housing in a prohibited area.
4. **Exceptions:** There are usually some exceptions to the ordinance, generally an exclusion if your conviction was as a minor, was pardoned, and/or a "grandfather clause" that allows you to stay in a prohibited zone if you resided in the home before the ordinance took effect or a prohibited business moved in after you established residence. Some municipalities also allow an appeals process made through a local "sex offender management board" which may be appealable through local courts. Even if you are considered an SVP, there may be an exception to certain rules if your residential placement is ordered by the courts.

The smaller the community, the harder it is to find online ordinances. The ONLY way to know for sure what current laws exist and are being enforced is by contacting the local registration office wherever you plan to move.

UNDERSTANDING WISCONSIN'S ADMINISTRATIVE DIVISIONS

Wisconsin's "Administrative divisions" can complicate matters when researching restrictions. There are three categories of divisions. Wisconsin is divided into counties, cities, villages and towns (known elsewhere as "townships"); cities and villages can overlap county boundaries. This also means that multiple locations have the same name. For example, the city of Algoma is in Kewaunee County while the town of Algoma is in Winnebago County. The database denotes the type of community.

The following info was extrapolated primarily from the League of Wisconsin Municipalities website (<https://www.lwm-info.org/>)

1. City: In order to incorporate as a city, a community must have at least 1,000 citizens if it is in a rural area or 5,000 if it is in an urban area. As of 2015, Wisconsin had 190 cities. Cities are broken down further into classes. The city of Milwaukee is the only first class city in Wisconsin. There are 16 cities of the second class, 30 cities of the third class and 143 cities of the fourth class.
 - a. Cities of 150,000 population and over constitute cities of the first class.
 - b. Cities of 39,000 and less than 150,000 population constitute cities of the second class.
 - c. Cities of 10,000 and less than 39,000 population constitute cities of the third class.
 - d. Cities of less than 10,000 population constitute cities of the fourth class.
2. Village: In order to incorporate as a village, a community must have at least 150 citizens if it is in a rural area or 2,500 if it is in an urban area. As of 2015, Wisconsin had 410 villages.
3. Town (or township): The word "town" has a different meaning in Wisconsin than in most other states. In Wisconsin, a "town" is a 6-mile by 6-mile parcel of unincorporated land within a county; Wisconsin towns are thus similar to civil townships in most other states. All residents of Wisconsin who do not live in an incorporated city or village live in a "town". As of 2015, Wisconsin had 1,255 towns.

NOTABLE STATISTICS AND FACTS IN THIS DATABASE

NOTICE: There are 1,922 total cities, villages, townships, and counties in the state of Wisconsin. Of those local-level governments, 577 local-level governments lacked online ordinances and/or did not respond to FOIA request, or had incomplete information on existing ordinances. Statistics below will be based on the remaining 1345 local-level ordinances reviewed for this report. Just over a fourth of communities with searchable ordinances have some form of restrictive ordinance.

Additional stats and notes:

- ❖ At least one ordinance passed every year since 2006: 2006 (1), 2007 (20), 2008 (26), 2009 (17), 2010 (11), 2011 (13), 2012 (8), 2013 (18), 2014 (17), 2015 (18), 2016 (23), 2017 (23), 2018 (7), 2019 (10), 2020 (15), 2021 (10), 2022 (6), 2023 (7), 2024 (3), 2025 (4). There are a few caveats worth mentioning here.
 - First, 86 communities with restrictive ordinances did not state an origin date for their laws.
 - Second, a number of communities had revised their code of ordinances in recent years, making pinpointing when a local-level ordinance originally passed.
 - Third, some communities had scaled back local residency restriction laws in response to *Hoffman, et al. v. Village of Pleasant Prairie*, Case No. 16-CV 697-JPS (E.D. Wis., 4/17/2017), which ruled the ordinance violated ex post facto and equal protection clauses. (The Pleasant Prairie ordinance had made 90% of the town off-limits and most of the remaining land was non-residential property.).
 - Wisconsin is a legal battleground for municipal residency restriction laws, but some recent rulings may inspire some municipalities to reinstate bad ordinances or encourage communities with ordinances to increase the distance of the restrictive ordinances. *Koch v. Village of Hartland*, No. 22-1007 (7th Cir. 2022) overturned prior rulings in *US v. Leach*, 639 F.3d 769 (7th Cir. 2011) & *Vasquez v. Foxx*, 895 F.3d 515 (7th Cir. 2018), concluded that the critical inquiry in assessing retroactivity is “whether the law changes the legal consequences of acts completed before its effective date.” The courts declared the Hartland ordinance was retroactive, and remanded the case back to the

US District Court to determine if the law is punitive. Residency restrictions were unsuccessfully challenged in *Nelson v. Town of Paris*, 616 F. Supp. 3d 844 (E.D. Wis. 2022), which upheld a local 6500 foot residency restriction ordinance.

- Unlike other states that allow local-level ordinances, passage of ordinances in WI are more evenly distributed among years, suggesting there is no singular event that triggered an explosion of local-level ordinance passage.
- ❖ Out of the different types of communities, cities are the most likely community type to pass a restrictive ordinance:
 - 154 of 416 villages (37%) have a restrictive ordinance
 - 3 out of 72 counties (4.2%) have a restrictive ordinance; Juneau and Keweenaw Counties have some presence/anti-loitering restrictions, and Walworth County passed an ordinance requiring the Lakeland Health Care Center (a nursing home) to deny admission to RPs
 - 88 of 1244 towns (7.1%) have a restrictive ordinance
 - 102 out of 190 cities (53.7%) have a restrictive ordinance
- ❖ The 11 communities with anti-clustering laws: Allouez (village) Cloverland (town), Coleman (village), Eagle River (village), Fredonia (town), Grafton (village), Howard (Village), Hustisford (village), Land O' Lakes (town), Somers (town), Somers (village), Union Grove (village), Yorkville (village)
- ❖ Communities that repealed their local restrictive ordinances:
 - Algoma (Town, Winnebago Co., Pop. 7,000), Repealed 8/22/2024
 - Brownsville (Village, Dodge Co., Pop. 598) Repealed 8/9/2017
 - Kimberly (Village, Outagamie, Pop. 7,675) Repealed 10/4/2021
 - Lake Geneva (City, Walworth Co., Pop. 8,684) Repealed 4/28/2025
 - Randall (Town, Kenosha, Pop. 3,285) Repealed 1/10/2019
- ❖ Registrants targeted by ordinances:
 - "Crimes Against Children": The law targets those with offenses against those under age 18 the most often (206), followed by offenses against those under age 16 (81); Off<17 (3), Off<15 (1) and Off<14 (1) were outliers; 38 ordinances effectively applied their ordinances to all Registrants even when not explicitly stated in the ordinance.
 - Offense category: Local-level ordinances most frequently targeted those convicted for a sexually violent offense (160) or those subjected to a "Special Bulletin Notice" (160); Lifetime Supervision (37), "Habitual" offenders (4), those on Supervised Released (3), those labeled a "Serious Child Sex Offender" (1), and those convicted of sexual assault (1) were rarely mentioned.
 - The majority of known ordinances, 299 of 347 (86.2%) targeted multiple categories of Registrants.
