

FLORIDA MUNICIPAL ORDINANCES AFFECTING PERSONS FORCED TO REGISTER
Database created by Derek W. Logue of OnceFallen.com, Most Recent Update: 14 AUG. 2026

ABOUT THIS DATABASE

Under Florida law, certain Registered Persons (i.e., persons forced to register for inclusion on the state's sex offense registry) are subject to residency restriction laws. The state's Residence Restrictions are found at: Florida Statutes (FS) §775.215

Florida conviction for offenses that occur on or after October 1, 2004, & for extra-jurisdictional/"out-of-state" offense for offense occurred on or after May 26, 2010: A person who has been convicted of a violation of FS §794.011, §800.04, §827.071, §847.0135(5), or §847.0145, regardless of whether adjudication has been withheld, in which the victim of the offense was less than 16 years of age, may not reside within 1,000 feet of any school, child care facility, park, playground, or swimming pool. State law also creates "Presence Restrictions" or proximity laws, i.e., laws that state you cannot loiter or be present at or near certain locations:

- RPs with conviction involving a minor cannot be within 500 feet "of place where children are congregating," & face restrictions on ability to be present in schools & parks with exceptions. FS §856.022
- For those whose offense was committed on or after May 26, 2010: It is unlawful for an RP to knowingly approach, contact, or communicate with a child under 18 years of age in any public park building or on real property comprising any public park or playground with the intent to engage in conduct of a sexual nature or to make a communication of any type with any content of a sexual nature. FS §856.022
- RPs on supervision cannot visit schools, child care facilities, parks, & playgrounds except with approval, & is there for religious reasons or if the parent of a child using the area. FS §948.30
- **NOTICE! Chapter No. 2026-17 added "public swimming pools" to list of both residency and presence restrictions; increased presence restrictions from 300 ft. to 500 ft., and allows warrantless arrests for violations of presence restrictions**

Florida allows municipal and county ordinances to create exclusions that exceed state law. The state's Office of Program Policy Analysis and Government Accountability (OPPAGA) reports that there were 196 local ordinances in Florida as of 9/2024. Statewide, 129 cities (31%) had at least one ordinance. The number of city ordinances varied widely by the county in which the city is located. Counties most commonly had one to two city ordinances. However, three counties had significantly more city ordinances—Broward (29), Palm Beach (16), & Volusia (13). Statewide, 32 counties (48%) had city ordinances. Forty-three counties (64%) had ordinances that were countywide or covered all unincorporated areas. Overall, 52 counties (78%) had at least one city or county ordinance within their jurisdiction. Between 2018 & 2024, 19 new ordinances were created. In addition to additional restrictions on distance and the number of locations that create prohibited areas, some municipalities have added anti-loitering/presence restrictions, anti-clustering laws (can't live within a certain distance of another Registrant), and prohibitions on using emergency shelters/segregated shelter policies. When taking county ordinances applied to incorporated areas, nearly half of Florida's communities have more draconian laws than those enforced statewide. This obviously makes finding housing that meets residency restriction guidelines difficult for Registered Persons required or willing to reside in the state of Florida. To date, no agency has publicly published a list of municipal and county ordinances. This database is part of the commitment of OnceFallen.com to create a database of municipal- and county-level codes across the US, including Florida.

DEFINITIONS

- **CHILD SAFETY ZONE:** Some ordinances may use this term as shorthand for the area covered under residency and/or presence restrictions. This term may, at times, be used interchangeably with “places where children congregate.”
- **FLORIDA STATUTES (F.S.):** The state laws of Florida, often shortened to the initials F.S.
- **INCORPORATED AREA:** An area within an “incorporated community,” i.e., a city or municipality. Incorporated land is governed by the city government, though county laws can override city government.
- **LOCAL-LEVEL GOVERNMENT (GOV’T):** For this report, “local level government” refers to city and county-level governments. Both city and county governments can pass laws targeting Registered Persons at the local level. Some counties choose to enforce county laws even in incorporated communities. Jacksonville/Duval County is unique for having a joint local-level government, making the city and county a single government entity.
- **LOITERING:** Municipal ordinances may vary on the definition of “loitering.” The state’s definition, as defined in FS §856.021—Loitering or prowling; penalty.—(1) It is unlawful for any person to loiter or prowl in a place, at a time or in a manner not usual for law-abiding individuals, under circumstances that warrant a justifiable and reasonable alarm or immediate concern for the safety of persons or property in the vicinity. (2) Among the circumstances which may be considered in determining whether such alarm or immediate concern is warranted is the fact that the person takes flight upon appearance of a law enforcement officer, refuses to identify himself or herself, or manifestly endeavors to conceal himself or herself or any object. Unless flight by the person or other circumstance makes it impracticable, a law enforcement officer shall, prior to any arrest for an offense under this section, afford the person an opportunity to dispel any alarm or immediate concern which would otherwise be warranted by requesting the person to identify himself or herself and explain his or her presence and conduct. No person shall be convicted of an offense under this section if the law enforcement officer did not comply with this procedure or if it appears at trial that the explanation given by the person is true and, if believed by the officer at the time, would have dispelled the alarm or immediate concern.
- **“ON PREMESIS” (OP):** Being physically present on land that is considered a prohibited property.
- **PARK BAN:** A law/ordinance banning Registered Persons from entering a place designated as park grounds. They can be a total ban, or a ban when a minor age<16 is present unless you’re that child’s parent.
- **“PLACES WHERE CHILDREN CONGREGATE”:** It is not clearly defined in State Statutes or in municipal ordinances; it is used as an open-ended, vague term that can apply to any place where children may decide to hang out. It doesn’t state how many children must “congregate.” This term is often used interchangeably with “Child Safety Zone.”
- **PRESENCE RESTRICTIONS (PRs):** Laws that restrict where a Registered Person may loiter, hang around, or even be merely present within distance of a prohibited zone. Ordinances mentioned within this report generally use two types of restrictions:
 - *Anti-Loitering Restrictions:* Designated by an “A” in the “PRs” section of the report, this means a local-level law prevents you from being within a prohibited area without a legitimate purpose. See the “Loitering” definition to see how the state defines loitering.
 - *Presence Ban:* Designated by a “B” in the “PRs” section of the report, this means a local-level law prevents you from being present for any reason at all in a prohibited area, barring specific exclusions allowed by law. Each local-level ordinance defines these exceptions to the rules. Common exclusions may include entering a restricted zone to consult with a lawyer/ social worker/ LEA, attend church/ school (with permission)/ employment, or gov’t meeting.
 - *Travel Ban:* In some instances, a complete ban on being present in a restricted zone may even include traveling through a restricted zone, except under certain circumstances. This is marked as a “(T)” under the PRs section of this report. Exceptions to the rule vary, but may include the following: Exceptions to the travel ban in the prohibited zone includes (1) meeting with a licensed attorney or Law Enforcement Agent (2)

interview with a licensed social service provider; (3) attending a school as a student, (4) medical appointment with licensed physician, (5) attend to familial/ parental obligations, (6) employment, and (7) seeking emergency shelter during a disaster/ terrorist attack if a school is designated as a shelter.

- **REGISTERED PERSONS (RPs)/REGISTRANTS:** A Person Forced to Register (PFR) for inclusion on the sex offense registry. We oppose the use of “registered sex offender” because it implies everyone on it is doomed to reoffend, and thus we use Registered Person, RP, or simply “Registrant” in this report.
- **RESIDENCY RESTRICTIONS (RRs):** The minimum distance your residence must be located from a prohibited area, generally measured “from property line to property line.” For Florida conviction for offenses that occur on or after 10/1/2004, & for extra-jurisdictional/“out-of-state” offense for offense occurred on or after May 26, 5/26/2010: A person who has been convicted of a violation of FS §794.011, §800.04, §827.071, §847.0135(5), or §847.0145, regardless of whether adjudication has been withheld, in which the victim of the offense was less than 16 years of age, may not reside within 1,000 feet of any school, child care facility, park, playground, or swimming pool. However, local-level ordinances may increase distance and/or number of prohibited locations within the city. In some instances, it can apply to a prohibited property just outside the community limit to use on a property within the community’s border.
- **“SEXUAL OFFENDER” (SO):** One of two legal designations for Persons Forced to Register. This is the lesser designation of the two. Every Registrant not designated by the state as a “Sexual Predator” is classified as a “Sex Offender”. See F.S. §943.0435
- **“SEXUAL PREDATOR” (SP):** A “Sexual Predator”, defined in F.S. §775.21, is an individual who has been convicted of a sexually violent offense as defined in Florida Statute 775.21 (which may include offenses from another jurisdiction) AND has a written court order designating the individual a sexual predator; OR An individual who is civilly committed under the Florida Jimmy Ryce Sexually Violent Predator Act AND has a written court order designating the individual as a sexual predator.
- **“UNINCORPORATED AREA”:** Any place in a county that is not considered part of a city and this not “incorporated.” County land not incorporated into a city is governed by the county.

HOW TO READ THE DATABASE

Categories are listed as follows (Note: See Definitions for further descriptions of terms used here):

- **Municipality/Co. Gov't:** Name of gov't entity/corporation; County gov't will have its own entry, noted by the abbreviation "(Co.)". Note that the county governments are allowed to pass ordinances that can apply countywide or only to unincorporated areas.
- **County:** The County in which the incorporated community is located. Some communities may span multiple counties.
- **Pop.:** Population of municipality or county
- **Residency Restrictions (RRs):** Measured in feet; if no ordinances exist, it will say "NA" but state restrictions still apply; a question mark ("?") means no definitive evidence of an ordinance or lack of one can be found; 1000 ft. statewide RRs still apply.
- **Presence Restrictions (PRs):** Any distance where you cannot be seen "loitering" (marked by an "A"), "be present within or near" (marked by a "B"), or a complete ban that includes a ban on even traveling through a restricted zone ("T"); distance is in feet. If no ordinance exists (marked by NA), or no ordinance could be confirmed (marked by "?"), then statewide presence restrictions of 500 ft. apply. "OP" means "on premises". "PB" stands for park ban.
- **Apply To:** The Registrants to which the additional rules apply. It should be assumed everyone listed as a "predator" is subject to the restrictions; however, in many cases, the law may state it applies to those convicted of offenses against those under age 16 ("Off<16") or age 18 (Off<18), which usually also applies to CP offenses. If they do not state any exceptions, it is assumed to apply to everyone forced to register. While not listed in this report, there are a number of exceptions to the ordinances. See the code for exclusionary details. Note: Some older codes use the term "sexual violator" typically defined as offenses against someone under age 16 or 18.
- **"1st Pass":** The date the municipality first passed a restriction ordinance. Generally, a mention of the date the ordinance can be found in municipal codes footnotes, except if superseded by a newer ordinance. This is intended to track the spread of ordinances across the state.
- **First Ord#:** The Ordinance number for the first known ordinance passed by that gov't.
- **Current Ord/Code:** The section in the municipal/county code of ordinances where the ordinance can be currently located.
- **Prohibited areas:** There are few points to remember regarding restrictions:
 - The prohibited areas are almost always going to involve children; "places where children congregate" is a commonly used phrase in codes/ordinances and can denote any place the municipality or county deems to be used primarily by children.
 - Unless otherwise noted, prohibited areas generally only apply to PUBLIC areas; they don't typically don't apply to privately owned areas like a private park or playground unless explicitly stated in the ordinance. County ordinance might also apply to incorporated areas (cities).
 - Additional notes regarding municipal/county codes impacting Registered Persons will be added to this section such as:
 - Emergency shelter provisions (identifying as a Registrant and/or being forced into a segregated shelter, like the Co. jail)
 - Registry fees
 - Anti-Clustering laws (laws preventing Registrants from occupying same bldgs. or within a set distance of another registrant)
 - Halloween/holiday activity restrictions as specifically noted in the codes (bans on passing out candy, dressing in costumes, attending parties/ festivals, and/or decorating houses, with exceptions)
 - Employment bans, such as bans on working as a delivery/transportation driver (cab, Uber, Lyft, etc.)

DISCLAIMERS

This database was created by reviewing every municipal or county code of ordinances available on the Internet. Many communities also post ordinances on websites like Municode (<https://library.municode.com/>), American Legal Publishing Corporation (<https://codelibrary.amlegal.com/>) and eCode360 (<https://ecode360.com/>). Some have their own websites. A community is only listed in this database if the municipal or county codes have been personally reviewed.

ACCURACY AMIND EVER-CHANGING LAWS: Municipal/county codes can change any time, and some municipal codes recently passed may not be reflected in this report. I've taken every step to verify info by direct review of city/county codes but if you find any errors, please email Derek Logue at iamthefallen1@yahoo.com

LANGUAGE & ABBREVIATIONS: While Once Fallen hates terms like offender and predator, they are legal terms used in these code/ordinances. At times, we use "SP" for those classified as "Sexual Predators."

ORDINANCES INCREASE STATEWIDE RESTRICTIONS: Please note that **Florida's statewide restrictions apply to ALL municipalities even if there are no residency or proximity ordinances in that municipality or county.** This means that if a municipality or county listed in this database does not have an ordinance affecting Registered Persons, state laws still apply to that municipality or county. This database ONLY reviews any ordinances passed at the county/municipal level.

EXCEPTIONS TO RESIDENCY RESTRICTIONS: Just as there are some exceptions to residency restrictions in the state law, ordinances may list a number of reasons a Registered Person can live within a prohibited area, such as when the registrant was a minor at the time of the offense or that the registrant was living in a location before a place that creates a prohibition area was established. See the municipal or county codes for further details. Unlike the state law, which does not apply residency restrictions to certain Registered Persons convicted on or after 10/1/2004 (or 5/26/2010 for certain offenses), most municipal or county codes lack an ex post facto prohibition statement. (I noted the ones that do.)

This report is not a treatise on the legality of these laws, but there are two county-level cases in which Registered Persons were excluded from local residency restrictions on ex post facto grounds. (See *City of Fort Lauderdale v. Anderson & Ford*, CASE NOS. 17-003615M010A & 13-010799M010A (17th Jud. Ct. Broward Co FL (10/23/2018)) and *State v. Wright*, Case No. 2018-CO-352 (4th Jud Ct, Nassau Co FL (4/24/2020)). In both cases, residency restrictions were determined to be punitive in nature (i.e., it is punishment) and so constitutional safeguards apply, specifically, protections against ex post facto (i.e., retroactively applied) laws. (That is a secondary reason for publishing the date the code first passed.) If you move into an area with residency and/or proximity laws, you may have to file litigation to fight for the right to live in that location.

ADDITIONAL NOTES ON RESIDENCY RESTRICTIONS: Most ordinances apply to prohibited areas outside the jurisdiction. This means if you live near the border of a city or county, and there is a school or other prohibited area near you but it is not in your city/county, it will STILL count as living in a "prohibited area" or "child safety zone." Every ordinance with a residency restriction ordinance also prohibits landowners from allowing Registrants to stay for free or rent from them if their properties are within these prohibited areas.

LOCAL-LEVEL RESIDENCY RESTRICTIONS (COUNTY LISTED ALPHABETICALLY, CITIES WITH EACH COUNTY LISTED ALPHABETICALLY)

WARNING! THIS DATABASE CONSISTS SOLELY OF ADDITIONAL RESTRICTIONS PASSED BY MUNICIPALITIES AND COUNTIES. EVEN IN AREAS WITHOUT THESE ADDITIONAL ORDINANCES, STATE SEX OFFENSE LAWS STILL APPLY! (STATE LAWS RESIDENCY RESTRICTIONS OF 1000 FT FROM SCHOOLS, CHILD CARE FACILITIES, PARKS, PLAYGROUNDS, & SWIMMING POOLS; AND PROXIMITY RESTRICTIONS OF 500 FEET FROM SAME AREAS, WITH SOME EXCEPTIONS).

COMMUNITIES IN SHADED AREAS ARE COVERED BY A COUNTYWIDE LAW; PLEASE CONSULT THE COUNTY ORDINANCE FOR DETAILS. IN INSTANCES WHERE THERE IS CONFLICT BETWEEN STATE AND LOCAL LAWS, THE LARGER OF THE TWO NUMBERS IS TYPICALLY THE DISTANCE ENFORCED BY LAW.

COUNTY NOTES

NOTICE! The state of Florida has added swimming pools to the list of statewide residency restriction laws, and increased presence restrictions to 500 feet. Municipal and county ordinances may not be changed to reflect these changes. STATE LAWS APPLY EVERYWHERE! In any conflict between two conflicting rules, ALWAYS assume the worse of the two is being enforced. Think of municipal and county laws as ADDITIONS to the statewide law.

BROWARD COUNTY NOTES:

- In only three municipalities, the ordinance denotes that residency restrictions apply only to those convicted after the date the ordinance passed or in adherence to the statewide restrictions: Ft. Lauderdale (10/1/2004), Lauderdale Lakes (10/1/2004), and Sunrise (8/9/2005)
- Of the 31 municipal codes (not counting county codes), only six municipalities have residency restrictions of less than 2500 feet: Davie (2000 ft.), Ft. Lauderdale (1400 ft.), Hollywood (1000 ft.), Lauderdale-By-The-Sea (2250 ft.), Oakland Park (2250 ft.), and Wilton (2000 ft.)
- According to the OPPAGA 2024 triennial report mentioned in the intro, 426 out 1,249 Registered Persons (34%) living in Broward County are homeless. The only other county matching Broward County in amount of homeless Registrants is neighboring Miami-Dade County.

HAMILTON COUNTY NOTE: The OPPAGA 2024 report claims there is a countywide ordinance for Hamilton County but I cannot confirm this since there is no information about it anywhere online. None of the communities or the county itself has published their municipal codes online.

HERNANDO COUNTY NOTE: The OPPAGA 2024 report claims Hernando County's restrictions are countywide, but it may be a misread of Sec. 21-232; that section reads "regardless of whether the" (prohibited area) "lies within unincorporated Hernando County." In this instance, it is referring to applying residency restrictions to a residence near/at the border of the county if a prohibited location is in the next county. No part of the ordinance explicitly states whether the ordinance applies to the sole incorporated community within.

INDIAN RIVER COUNTY NOTE: The OPPAGA claims Indian River County's residency restrictions/Sec. 306.06 ordinance is countywide; only the registry fee/ Sec. 306.07 ordinance is noted as applying countywide.

LEE COUNTY ADDITIONAL NOTES: Any county/state/federal law that is more restrictive than those of Ft. Myers or Lee County is enforced over the limits in their codes (See Ft. Myers Code §50-146, Lee Co. Code §19-56)

MIAMI-DADE COUNTY NOTES: The Miami-Dade County Ordinance nullifies all municipal codes to create a unified countywide ordinance that applies to all municipalities equally. However, municipal codes and ordinances are still on the books for many counties. I have left the municipal code info in this report for those seeking further research on prior residency restrictions in Miami-Dade County, but to avoid confusion among those just seeking current laws in place, I have opted to show only the ordinances below. Miami-Dade Co. has the second highest percentage of Registered Persons who are homeless (514 of 1,642, or 31%), behind Broward Co., according to the 2024 OPPAGA report.

NASSAU COUNTY NOTES: The definition of "facilities" in the Nassau Co. Residency restriction code was so long, it could not fit in the spreadsheet. See Nassau Co. Code, Sec. 19-26 – Definitions: "Facility means those areas of real property for which a zone or area of protection is established. They are defined areas

and locations devoted to use, and which possess a character and usage, which makes them places where children regularly congregate in, concentrated numbers. They are further described as: Places of public amusement or attraction such as auditoriums, arenas, bowling alleys, exposition and fairgrounds, waterslides, miniature golf courses, theaters and stages or other facilities for film or the visual and performing arts, and the like; state, county, municipal, and privately owned community centers, youth centers, parks, playgrounds, and recreation centers; athletic and recreational facilities and venues, including baseball fields, basketball courts, football fields, parks, pools, public or private golf courses, racquetball courts, soccer fields, tennis courts, volleyball courts, and skate parks; bathhouses and public restroom facilities; boat ramps, docks, fishing piers, marinas, public beach access and dune walk-overs; camps, family day-care homes, nurseries, and child care facilities, whether public, religious, or private, including, but not limited to, those licensed by the department of children and families; churches, temples, and places of worship, which have child-care, youth centers, and/or regular religious instruction and programs for youth; private, religious, or state, county, and municipal buildings, which have day-care facilities, and/or schools and institutions of learning, (but specifically excluding jails and places of adult or juvenile detention). "Schools" shall also include public or private school designated bus stops; facilities devoted to health care needs of children, including the clinics, offices, and medical facilities of doctors, dentists, orthodontists, optometrists, and other health-care providers, clinics, and the like which are devoted to the health-care needs of children."

For Presence Restrictions: It shall be unlawful for any sexual offender or sexual predator to be present in any public or private park or within two thousand five hundred (2,500) feet of any public beach access or dune walk-over, or upon or within any other recreational facility that is open to the public when:(1)A child under the age of sixteen (16) years is present in that park or within fifty (50) feet of such public beach access or dune walk-over, or within the boundaries of such other public recreational facility; and(2)Specific notice, as provided in this division, is provided by posting the facility at its entrance or entrances, or, absent specific entrances, every one hundred (100) feet along the boundaries thereof.

It is not specified in the code that the residency/proximity restriction ordinances are in effect countywide; while the 2024 OPPAGA report claims that it is, only the registry fees (Div. III of Ch. 194, Art. II) states that "This division shall apply to incorporated as well as unincorporated areas of the county."

OSCEOLA COUNTY NOTES: Osceola County Code, Sec. 14-78. – Applicability, states, "This article shall apply to, and be effective within the unincorporated areas of the county and within incorporated Osceola County, to the extent that the ordinance does not conflict with any municipal ordinance covering the subject matter, activity or conduct regulated herein." This applies to Kissimmee. There is a conflict between the city of St. Cloud and the County; the county adds school bus stops, libraries, and "other place(s) where children regularly congregate" to the list of prohibited places, while St. Cloud does not.

PUTNAM COUNTY NOTES: Putnam County Sheriff Homer "Gator" DeLoach has routinely harassed Registered Persons to compel them to move. In February 2025, he exploited building code ordinances to shut down a trailer park housing a few Registered Persons, referring to the park as a "cesspool" of "SOs", adding in a media interview, "Not in Putnam County and over my dead body are we ever going to let Putnam County become a sanctuary for these kinds of individuals." He advocated for the Putnam Co. Ordinance, which passed in 2025. All pending ordinances in the county appear to have the same restrictions if they pass.

APPENDIX: VARIOUS STATISTICS FROM THIS REPORT

Florida is often seen as the most onerous states for a Registered Person to reside. Politicians on the state and local level often gleefully pass laws and have expressed open hostility towards Registered Persons while passing such laws.

There are 67 counties and 411 incorporated municipalities in Florida. I was unable to retrieve a total of 34 municipality/county ordinances.

APPENDIX NOTES:

- **Asterisk(*):** This includes ordinances remaining on the books despite being nullified by a superseding ordinance, as in Miami-Dade County, or ordinances that simply enforce an ordinance otherwise applied to a county; Jacksonville and Duval County share a governing body. This impacts 41 municipalities for residency restrictions.
- **Double Asterisk (**):** Altha (Pop. 496) is covered by a county ordinance but does not have its own ordinance)
- **Caret(^):** Santa Rosa has a park ban but not a “child safety zone” and so is excluded from this count.
 - **How local-level ordinances are applied:** 117 local-level ordinances apply to those whose offenses are against persons age 16 or younger (age<16); 22 local-level ordinances apply to those whose offenses are against persons age 18 or younger (age<18); 48 local-level ordinances apply to everyone on the sex offense registry (ALL), and 15 local-level ordinances apply to those classified as “S*xual Pr*dators” (SPs). Some municipalities had multiple categories, such as applying it to Age<16 & SP convictions.
- **Counties known to apply their ordinances countywide (17):** Brevard (only Presence Restrictions), Calhoun, Columbia (but only including Ft. White), Glades, Hardee, Holmes, Jackson (only heavily implied, not explicitly stated), Lee, Madison, Miami-Dade, Okeechobee (only segregated shelter), Osceola, Pasco, Polk, Putnam (fees only), St. John’s, and Washington (implied). This makes accurately counting number of ordinances difficult. The number of

ordinances and the number of communities that are under countywide laws that exceed state laws is greater than the number of local government with such laws on the books.

- **Counties where no residency or presence restrictions exist, as of 8/14/2026 (12):** Charlotte, Dixie, Escambia, Franklin, Gadsden, Gilchrist, Highlands, Jefferson, Leon, Monroe, Sarasota, Wakulla. This can change at any time, and some communities in these counties have other laws in the books like employment restrictions.
- **Counties with Halloween/Holiday Restrictions (7):** Clay, Duval, Hernando, Nassau, Pasco, Putnam, and St. Johns. Palatka (Putnam Co.) is a county with Halloween/Holiday Restriction ordinances in place, and the remaining Putnam Co. communities are advancing similar ordinances.
- **Residency Restriction Ordinance Stats:**
 - **The 2500 ft. distance is by far the most used distance:** Of the counties and cities with residency restrictions, 143 municipalities and county ordinances explicitly state they enforce 2500 foot residency restriction ordinances; when adding the 73 communities without their own residency restriction ordinances but are covered by countywide ordinances, there are 212 Florida cities and counties in total that enforce residency restrictions of 2500 feet. This alone means 44.3%, nearly half of Florida local governments; enforce 2500 ft. residency restriction laws. Three counties (Holmes, Jackson, and Washington) covering 18 communities only imply their 2500 restrictions apply statewide; if taking them into account, then 48.1% of Florida cities and counties have residency restrictions of 2500 feet.
 - **Communities with distances exceeding state law:** In total, at least 230 cities and counties (49.6% of all FL communities) have residency restriction laws exceeding the state's 1000 foot residency restrictions; Three counties (Holmes, Jackson, and Washington) covering 18 communities only imply their 2500 restrictions apply countywide; if taking them into account, then 51.9% of Florida cities and counties have residency restrictions exceeding state law. In addition to the 178 with 2500 foot restrictions, 1 has restrictions of 3000 feet, 2 have restrictions of 2250 feet, 8 have restrictions of 2000 feet, 13 have restrictions of 1500 feet, and 1 has restrictions of 1400 feet. Another 19 cap the restrictions at 1000 feet but add numerous restricted areas. One community (Anna Maria, Manatee Co.) has additional restrictions of 150 feet that include stops for the local trolley.
- **Presence Restrictions Stats:**
 - **Total Presence Restrictions:** There are only 50 individual ordinances that add some kind of presence restriction ordinance; however, many such ordinances are countywide and this cover 141 communities, or 29.5% of Florida's communities.
 - **Anti-Loitering:** A total of 95 communities are subject to municipal anti-loitering ordinances; of those, only three communities—Dundee (Polk Co.), Oldsmar (Pinellas Co.), and West Palm Beach (Palm Beach Co.)—are in counties without additional presence restriction ordinances. The remaining communities are covered by countywide ordinances in Broward, Lee, Martin, Miami-Dade, and Pasco Counties.
 - **Complete Bans:** A total of 31 cities and counties ban Registered Persons from being present in a restricted zone. Of those, 14 have prohibitions on even traveling through a restricted zone. Countywide travel-through restrictions include Calhoun, Flagler, Lake, Seminole, and Union; only Calhoun Co. explicitly states the ordinance is enforced in incorporated communities, covering two communities.
 - **Park and/or Recreation (Rec.) Center Bans:** Eleven local-level ordinances cover park bans; only three counties—Glades, Okeechobee, and Santa Rosa—have park bans, and only Glades County enforces a countywide ban, affecting one city (Moore Haven). Two cities added Recreation Centers to their Park Bans—Daytona Beach Shores and Lake Helen, both of which are in Volusia County.
- **Emergency Shelters & ID Checks:**
 - **Counties with Present ID orders and/or Segregated Shelter Ordinances (21):** Calhoun, Citrus, Clay, Collier, Columbia, Duval, Glades, Hendry, Hernando, Highlands, Indian River, LaFayette, Lee, Madison, Martin, Okeechobee, Osceola, Putnam, Sumter, Sevanee, and Union. Madison & Union Counties require Registrants to identify as a Registrant when entering a shelter, which is a prerequisite for segregation, but segregated shelters are not explicitly stated in the ordinance.

- **Counties that require you to carry State ID at ALL times (3):** Lafayette, Madison, and Sevanee
 - **Green Cove Springs (Clay Co.):** Has an ordinance requiring shelters and vacation rentals be at least 1000 feet from a business, school, child care facility, park, playground, or other places where children regularly congregate
- **Counties with an Anti-Clustering Ordinance (4):** Glades, Hillsborough, Lake, Putnam; the cities of Fruitland Park (Lake), Moore Haven (Glades), and Palatka (Putnam) are in counties with anti-cluster ordinances in place, and the remaining Putnam Co. communities are currently advancing similar ordinances.
- **Counties with Registry Fees Ordinances (6):** Collier, Indian River, Lee, Nassau, Polk, Putnam; Palatka (Putnam) is a county with registry fee ordinances in place, and the remaining Putnam Co. communities are currently advancing similar ordinances.
- **Ex Post Facto Statements:** Only 6 municipal ordinances explicitly state the ordinances do not apply to those convicted before a certain date—Del Ray Beach, Ft. Lauderdale, Lauderdale Lakes, New Port Richey, and Pasco County use the same 10/1/2004 date as the state law, while Sunrise does not apply the ordinance to those convicted before 8/9/2005
